

## Childbirth Lump-Sum Allowance (Shussan Ichiji Kin)

### [Explanation]

In case of childbirth, you will receive a Childbirth Lump-Sum Allowance as a support for the costs of childbirth.

#### <Childbirth after April 1st, 2023>

Payment amount	Requirements
500,000JPY	Deliveries after at least 22 weeks of pregnancy at a medical institution which is a member of the Maternity medical care compensation scheme
488,000JPY	In case of the following (1) or (2), (1) Deliveries after 85 days –less than 22 weeks of pregnancy (2) Deliveries after at least 22 weeks of pregnancy at a medical care institution which is NOT a member of the Maternity medical care compensation scheme

#### <Childbirth until March 31, 2023>

Payment amount	Requirements
420,000JPY	Deliveries after at least 22 weeks of pregnancy at a medical institution which is a member of the Maternity medical care compensation scheme
408,000JPY	In case of the following (1) or (2), (1) Deliveries after 85 days – less than 22 weeks of pregnancy (2) Deliveries after at least 22 weeks of pregnancy at a medical care institution which is NOT a member of the Maternity medical care compensation scheme

You need to pay a large amount of expenses temporarily at medical institution since the Lump-Sum Childbirth Allowance will be applied for and paid after childbirth. You can use "the system of direct payment of Childbirth Lump-sum Allowance to medical institutions" or "the system of receipt of the Childbirth Lump-sum Allowance directly by the medical institutions on your behalf". If you use these systems, you can pay at the medical care institution only the amount of childbirth expenses minus the amount of the Lump-Sum Childbirth Allowance.

If the childbirth expenses are less than the amount of the lump-sum childbirth and childcare allowance, the difference will be paid to you by the Nissan Kenpo.

【Program (to be chosen)】

**(1) The system of direct payment of Childbirth Lump-sum Allowance to medical institutions**

Nissan Kenpo pays the lump-sum birth and childcare allowance directly to medical institutions to cover childbirth expenses.

**(2) The system of receipt of the Childbirth Lump-sum Allowance directly by the medical institutions on your behalf**

Advance application to designate the medical institutions where you plan to give birth as the direct recipient of the Childbirth Lump-sum Allowance on your behalf.

**(3) Reimbursement from you to Nissan Kenpo**

You will claim to Nissan Kenpo with the invoice.

【How to apply】

The procedure differs by program.

**When using (1) The system of direct payment of Childbirth Lump-sum Allowance to medical institutions**


Please check with the medical care institution where you plan to give birth. The documents of agreement to use this program between you and the medical institution where you plan to give birth needs to be completed.

**When using (2) The system of receipt of the Childbirth Lump-sum Allowance directly by the medical institutions on your behalf**

Required documents for submission	Childbirth Lump-Sum Payment Request Form (出産育児一時金請求書 (受取代理用) Shussan Ikuji Ichijikin Seikyu Sho – Uketori Dairi You)
Other required documents	Copy of Mother and Child Handbook (母子手帳 Boshi Techo) ① A cover page with the names of the mother and child ② A page with the expected date of delivery
Eligible person	Insured persons and dependents who are expected to receive the Childbirth and Childcare Lump-sum Grant and who are scheduled to give birth within two months
Deadline	Within 2 months before the expected date of delivery

### (3) Reimbursement from you to Nissan Kenpo

Required documents for submission	Childbirth Lump-Sum Payment Request Form (出産育児一時金請求書 Shussan Ikuji Ichijikin Seikyu Sho)	
Other required documents	(1) "Document of agreement of agreeing not to use the direct payment system" issued by the delivery institution (2) Copy of receipt which confirm payment of delivery expenses (3) Copy of the part with the following seal (image) (It is stamped on the receipt or invoice. If it is stamped on the receipt, it is OK to submit (1) and (2)) 	
Eligible person	Insured persons and dependents who did not use the "The system of direct payment of Childbirth Lump-sum Allowance to medical institutions" nor "The system of receipt of the Childbirth and Childcare Lump-sum Grant directly by the medical institutions on your behalf" and paid all delivery expenses at the medical institution	
Deadline	Apply promptly. The maximum billable period is two years from the day after the date of delivery.
